World Partners will set-up an almond orchard with modern **irrigation and tree management techniques**. This will bring employment opportunities and technical knowledge to the region. The income from the farm will support local church growth and provide for the set-up of similar businesses in the future.

Finances overview

With your donation, World Partners can initiate this business and realize the impact in this country.

The total investment for the set-up is € 550.000. The almond trees start producing nuts after 3 years, and are at maximum producing capacity after 6-7 years. The trees from the nursery can be sold annually, starting from year 2. Including depreciation and land purchase, the return on investment is projected at 10 years, at an annual profit of € 110.000.

The finances will be used as **revolving funds**: with the profits of this business, we will initiate and support similar agricultural projects in this region, to maximize the impact of your donation.

Experience from Central Asia

Five years ago, World Partners started a similar company in Central Asia. This business started as a 30-hectare apple orchard and is now successfully producing quality apples for the local market. In addition, we started a tree nursery at the orchard, where we grow and sell 60.000 quality trees annually, as well as we have implemented irrigation systems at over 20 orchards in the region.

Through these activities, this business has significantly improved the local value chain and provides mission opportunities on a daily basis. With the **know-how and experience from this proven concept** we want to implement the same model in a new region, to improve the local value chain and reach a whole new area with the good news of God.
